

MEMORANDUM OF UNDERSTANDING

SUBJECT: Full Time National Guard Duty Operational Support (FTNGDOS), and Recruiting and Retention Global War on Terrorism (FTNGDGWOT)

1. By initialing below I understand that by applying for a FTNGDOS/FTNGDGWOT:

_____ I will be placed on FTNGDOS/FTNGDGWOT orders for the entire period of the mission. My orders will not be "broken" to perform IDT, or AT.

_____ My commander has / has not (circle one) authorized me to perform my IDT and AT with the unit I am on FTNGDOS/FTNGDGWOT orders with

_____ I cannot enter FTNGDOS/FTNGDGWOT if I am entitled to separation pay, sanctuary or retirement benefits. This program is not designed to be a career program.

_____ I am not eligible for a PCS

_____ I will be entitled to all pay and benefits due to me on a "long tour", to include health and dental if my orders are more than 30 days. This may require my dependents to update or be issued new I.D. cards.

_____ I will accrue 2.5 days leave per month; I am authorized to use the leave I accrue while on orders with approval from my OIC. I will be required to use **all** accrued leave. Leave may not be paid. (EXCEPTION: A member may reduce his/her tour by the number of days accumulated at the end period to cover paying leave however, this would result in a net loss of money due to the fact the member would not be paid BAS and BAH) I understand that as a result of not being able to sell leave, I may "lose" leave that I have not used. I agree to submit a DA Form 31 for all unused leave prior to the end of my tour and prior to receiving my DD 214/DD 220.

_____ I am not in/will not be in a technician status on LWOP or Military Leave.

_____ I will not have served greater than 17 years active service as a result of this duty

_____ If I am injured during my duty on FTNGDOS I will complete an LOD through my unit with assistance from my FTNGDOS supervisor.

_____ Before the start of the proposed duty, I will waive sanctuary and consent to release from Full Time National Guard Duty at the conclusion of my tour of duty by signing block 24 of the ARNG Form 1058-R (Jul 02).

_____ I may be involuntarily released from FTNGDOS/FTNGDGWOT orders for the following reasons:

- (1) My conduct, degree of efficiency, or manner of performance is seriously deficient.
- (2) Funds available for FTNGDOS/FTNGDGWOT tours are curtailed.
- (3) If I am promoted or appointed to a higher grade based on my traditional National Guard unit of assignment and no longer compatible with the duties performed in my FTNGDOS/FTNGDGWOT duty position, or cause "grade inversion".
- (4) If there is a change in mission requirements that results in no further need of the soldier's skill/pay grade.

_____ I am subject to all disciplinary actions within established state regulations and guidelines to include NGRs 600-100, 600-101 and 600-200.

_____ I will be issued appropriate separation documents by my Program Manager, upon completion or release of duty. A DD Form 214 will be issued for duty more than 90 days or a DD Form 220, for duty less than 90 days.

_____ I will keep my chain of command informed of any changes in my personnel, medical and/or military status.

_____ My Operational Support duty may be included in my NCOER under "Appointed Duties" in Part III. FTNGDOS duty will be included in my annual NCOER issued by my unit chain of command. FTNGDOS duty may be included in my NCOER.

2. I understand that if I have withheld or falsified any information that would make me ineligible for a tour at time of application, I will have my orders terminated immediately.
